

SIXTH TRIENNIAL SESSION, A. L. 5865.

Monday, October 16th, A. L. 5865.

The Sixth Triennial Session of the Most Worshipful National Grand Lodge of Free and Accepted Ancient York Masons, assembled in the Hall of the M. W. Union Grand Lodge for the State of Maryland, corner of Saratoga and Davis Streets, in the City of Baltimore, and was opened in ample form, in the Third Degree of Free Masonry.

The minutes of the afternoon session of yesterday were read, and, on motion to approve, an amendment was offered, to strike from the minutes so much as relates to the Brothers from Norfolk and Portsmouth, Va. The N. G. Master decided the amendment out of order. The minutes were then approved.

Motion, by M. W. Brothers Samuel W. Chase, Sr., and Nath. L. Durham, that Peter Wilson, W. M., of Rising Sun Lodge, of Norfolk, Va., and John W. Jasper, W. M., of Morning Star Lodge, of Portsmouth, Va., working under authority from the M. W. Union Grand Lodge, for the State of Maryland, be admitted to honorary membership of this M. W. N. G. Lodge. After considerable discussion the motion was lost.

Motion, by Brother J. B. Smith, M. D., that no motion shall be entertained in this M.W. N. G. Lodge except the same be submitted in writing.

Amendment, by Brother Nath. L. Durham, that the word motion be stricken out, and the word "Resolution," be inserted; and that the words, "excepting motions on rules of order and business," be added thereto. After discussion, the amendment and motion was withdrawn by common consent.

Longfellow and Joseph G. Walker.

The Committee on Credentials stated through their chairman that they had ascertained that the credentials of Bro. Peter Hawkins, from M.W. Prince Hall Grand Lodge, are not regular, he not being a P.G. Master; therefore can represent but one vote for said Grand Lodge.

On motion, by Jonathan Davis and R. H. Gleaves, that whereas the credentials of Bro. Peter Hawkins are not in accordance with the letter and spirit of the resolution passed in National Grand Lodge, October 9, 1862, therefore, resolved, that the approval of the credentials of Bro. Hawkins be and is hereby reconsidered.

Pending the consideration of the above preamble and resolution the morning hour expired, and the M.W. N. Grand Lodge was called off until 3 o'clock, P. M.

AFTERNOON SESSION.

Tuesday, October 17th, A. L. 5865.

The M. W. N. Grand Lodge was called to labor at 3 o'clock. M.W. Paul Drayton, N. G. Master, presiding. Other officers in the stations as in the morning. The minutes of the morning session were read and approved.

The preamble and resolution pending at the close of the morning session was taken up. Thereupon it was resolved, that the question be

taken without further debate. Motion carried.

Resolved, that the credentials of Brother Peter Hawkins be returned to him, and that the Grand Master of Prince Hall Grand Lodge cast the votes of the Representatives of said Grand Lodge, who are not in attendance on this triennial session. Resolution carried.

The N. G. Master called for the reports from the Grand Lodges,

which were handed to the Committee on Grand Lodge reports.

A communication purporting to be from a General Assembly of F. A. M., convened at the City of Philadelphia, on the 10th, 11th and 12th days of October, was read, to wit:

"To all whom it may concern:—Greeting:—At the General Assembly of Grand Lodges, F. A. M., convened in the City of Philadelphia, on the 10th, 11th and 12th days of October, A. L. 5865—A.D. 1865, the following report of the Committee on Masonic Union, and the resolutions appended were adopted.

"REPORT.

"That there exists an unhappy disunion in the Masonic fraternity is a source of deep regret. The cause of this division, we think, is no doubt attributable to the irregularities that have crept into the fraternity, for the want of proper instructions relating to the laws and principles of the institution, especially in the organization of the 'National Grand Lodge,' which destroyed, we think, one of the great principles of the Fraternity in the government of the Craft, by claiming the right to hold Grand Lodges and Grand Masters subordinate to its decrees. We are fully satisfied that the time has arrived when there should be a unity of feeling and sentiment on this question among Masons, because we are placed in a very different position from any other class of men in the country, and for the additional reason that no matter what may be our differences to-day, we all emanated from the same original source, and are laboring to attain the same common end—the elevation of our fellow-men.

"Your committee are of the opinion, that an honorable union, without compromising any cardinal principle of the ancient usages and customs of the fraternity, ought to be formed. They think, that should the system of government known as the 'National Grand Lodge,' be abandoned by that body, the Grand Lodges in the several states could immediately take measures to unite upon the basis of common Masonic usage, for the government of the craft.

"That the question of Grand Lodge sovereignty is one that is generally conceded by both parties; this being the case, we hence fully believe, that should the 'National Grand Lodge' adopt the proper measures whereby all can meet on a common platform, the Grand Lodges here represented, should encourage and promote all efforts made to reconcile the difficulties which unfortunately divide a fraternity, that, above all others, should be united.

"Your Committee would respectfully submit the following reso-

lutions :-

"Resolved, That this General Assembly of Grand Lodges, after a mature consideration of our Masonic difficulties, think, that the only obstacle which stands in the way of a perfectly consistent Masonic Union, is the organization of the 'National Grand Lodge.'

"Resolved, That in union there is strength, and any obstacle or obstacles which stand in the way of our presenting an unbroken Ma-

sonic front, should be immediately removed.

"Resolved, That the Representatives here assembled, be requested to present, agitate and encourage in their respective Grand Lodges, fraternal visitations throughout the Fraternity.

"Resolved, That a copy of this report be prepared and transmitted

to the National Grand Lodge, for their consideration.

After the reading of the communication the following resolutions were submitted by Bros. John B. Smith, M. D., and R. H. Gleaves, viz:

Resolved, That in view of the fact that the proposition presented to this Most Worshipful National Grand Lodge, through a committee appointed by the Convention recently held in the City of Philadelphia, demanding, as it does, such concessions and action on the part of this Most Worshipful National Grand Lodge, as would not only be incompatible with the position of this Most Worshipful body, but also subversive of the proposed objects of the aforesaid proposition, and the purposes which the existence and character of this Most Worshipful National Grand Lodge is designed to accomplish.

Resolved, That the proposition of the aforesaid Convention is not of a character to be entertained by this Most Worshipful National Grand Lodge, and that it therefore be returned to the Committee from which

it came, accompanied by correct copies of these resolutions.

The afternoon hours having expired, the M. W. National Grand Lodge was called off, until the 18th, at 9 o'clock, A. M.

Wednesday, October 18th, A.L. 5865.

The M. W. National Grand Lodge was called on at 3 o'clock.

M. W. Bro. Paul Drayton, N. G. Master, presiding. Other officers in their stations, as in the morning. Minutes of the morning session read and approved.

The following Preamble and Resolutions were presented by Brothers

J. B. Smith and Jonathan Davis :-

Whereas, pursuant to circular call, issued by the African Grand

Lodge of the State of Massachusetts, Delegates from all the Grand Lodges of Masons, (colored,) in the United States of America, convened in the City of Boston, State of Massachusetts, on the 24th day of June, A. L. 5847, A. D. 1847, for the purpose of establishing a National Grand Lodge, as the most proper and efficient means of effecting and maintaining the principles of Masonic harmony and *Union* among the different Lodges of Masons throughout the country; and,

Whereas, all the said Grand Lodges of Masons, through and by their Delegates, in Convention assembled, did enter into a solemn covenant, to form, erect, constitute and establish a National Grand Lodge of the United States of North America, and to be subject to its jurisdiction; and,

Whereas, certain parties in and of the States of Pennsylvania, New York, New Jersey, Delaware, Maryland and California, have, in violation of their most sacred and solemn covenant, rebelled against the rightful authority of the Most Worshipful National Grand Lodge thus formed and constituted, and do still refuse to submit to its jurisdiction; therefore, be it, and it is, hereby

Resolved, That the said parties and persons as above, by the perpetration of this great Masonic crime, have placed themselves beyond the limits of proper Masonic recognition, and so long as they persist in occupying their present position, they can have no Masonic standing with this National Grand Lodge, nor can those under its jurisdiction acknowledge or respect them as Free and Accepted Masons; and all the members of this Most Worshipful N. G. Lodge, and all those working under its compact or jurisdiction, are hereby prohibited from countenancing the said assumed Lodges or persons as such, or those in any way connected with them, as Masons.

Resolved, That, as the purposes of the organization and maintainance of the Most Worshipful National Grand Lodge, was, and still is, to promote and effect the proposed Union of all Colored Masons in this country, we do hereby declare, that our hands continue to be extended towards all true and worthy brother Masons, and that we are also ready to receive into our fellowship, even those who are disaffected, whenever the proper application shall be made on their part to be thus affilliated.

After the reading of the above preamble and resolutions, it was on motion, they be adopted. Motion carried, unanimously.

The Committee on Grand Lodge Reports submitted the following, viz:

And be it further resolved, that it shall be the duty of the M.W. N. G. Master to make a full report of all such Lodges which may be opened and constituted in accordance with this preamble and resolutions, at the next communication of the M.W. N. G. Lodge, succeeding the

opening and constituting such Lodge or Lodges, as aforesaid.

Resolved, that in all cases where there may be a constitutional number of Master Masons wishing to be constituted into a Lodge of such, and to be located in a State or Territory where there is no Grand Lodge working under the jurisdiction of this M.W. Grand Lodge, now assembled in Baltimore, October, 1865, do now affirm, that so much of the report of the proceedings of the Grand Convention in Philadelphia, July, 1856, relative to the action of her Subordinate Grand Lodges, in the establishment of Lodges, until otherwise ordered.

After a spirited discussion on the above resolution, Bro. Jonathan Davis offered the following as a substitute, which was seconded by Bro.

John H. Butler.

Resolved, That the exclusive right of Grand Lodges to establish Subordinate Lodges in States or Territories where there are no Grand

Lodges, under the authority of this M. W. N. G. Lodge, resides in the nearest Grand Lodge to said State or Territory.

A spirited debate ensued, when it was, on motion, decided that a vote on the substitute be taken without further debate. Motion carried.

The vote being taken on the substitute, it was lost.

Motion to extend the time ten minutes.

Amendment, to extend the time until the disposal of the resolution now under consideration.

On the question of the amendment being taken, it was lost. The motion to extend the time to ten minutes was carried.

Further debate on the resolution of Bro. J. F. Cook was suspended,

for the purpose of receiving the following:

Resolved, That there be a Committee appointed, consisting of one from each State Grand. Lodge, to draft resolutions of condolence on the demise of M. W. Brother John T. Hilton, P. M. W. N. G. Master, and M. W. Brother Edward M. Thomas, late N. G. Secretary, and M. W. Bro. Wm. Tunion, late G. Master of the M. W. Union G. Lodge for the District of Columbia.

Resolution adopted.

Thereupon M. W. Brothers John B. Smith, of Massachusetts; Lewis A. Hood, of New York; Edward B. Hebrew, of Rhode Island; Obadiah L. Davis, of New Jersey; Joseph G. Walker, of Delaware; Sam'l W. Chase, of Maryland; Wm. H. Thomas, of District of Columbia; John W. Harrison, of Indiana; Samuel Van Brakle, of Pennsylvania; and Richard Howell Gleaves, of Ohio, were appointed said committee.

Resolved, That a page be inscribed in the minutes for each of the

above named deceased brothers. Adopted.

The M. W. N. Grand Lodge was called from labor until Monday morning, 9 o'clock, A. M.

A vote being taken on the adoption of the resolution of Bro. J. F.

Cook, it was lost.

On motion, the proposed new Constitution was read.

Thereupon M. W. Bro. R. H. Gleaves offered the following:

Resolved, That the Constitution just read, which has been submitted by the committee for the government of this M. W. N. G. Lodge, be received, and laid over until the Seventh Triennial Session (1868) of this M. W. N. G. Lodge for final action, and that said Constitution be printed with the proceedings of this Triennial Session.

And be it further Resolved, That the adoption of the aforesaid Con-

stitution shall be the first business in order after report of Committee on Credentials.

The above resolutions were, on motion, adopted.

Motion by Bro. Lewis Hayden:

Resolved, That Constitutions and enactments inconsistent with the new Constitution shall, on the adoption thereof, be, and the same is hereby repealed. Adopted.

Motion by Bros. N. L. Durham and Wm. E. Gipson:

Resolved, That any member of this M. W. N. G. Lodge, who shall delegate a Brother to this M. W. N. G. Lodge as his proxy, and subsequently present himself at any stage of the session, shall be allowed to withdraw his proxy thus delegated, but should he withdraw before the conclusion of the Triennial Session he cannot again delegate his privileges to the same session. Adopted.

The names of the original founders of the M. W. N. G. Lodge were

called for, and, on motion, their names were read.

A communication from M. W. Bro. John Jones, G. M. of the M. W. G. Lodge for the State of Ohio, appointing M. W. Bro. R. H. Gleaves proxy to represent said M. W. G. Lodge, was read, and, on motion, it was received.

The morning hour having expired, the M. W. N. G. Lodge was called from labor until 3 o'clock P. M.

Other officers in their stations, as in the morning.

Minutes of the morning session read, and, on motion, approved.

A petition from the Baltimore Publishing Company was read, and, on motion, referred to the Committee on Correspondence.

W. Bro. Jonathan C. Miller, N. G. Marshal, having been excused from further attendance on this session, M. W. Bro. R. H. Gleaves was received as his proxy.

The printed proceedings of the M.W. G. Lodge for the State of Ohio, having been referred to the Committee on Returns made the fol-

lowing report, viz:

The committee to whom was referred the printed proceedings of the M.W. G. Lodge for the State of Ohio, report, that they have examined the same, and find that there are eighteen chartered Lodges under its authority, and two under dispensation, with a total membership of 531. Total number of degrees conferred, 330.

The Lodges under dispensation, are styled Fulton Lodge, No. 9,

and Excelsior Lodge, No. 11.

Your committee are of the opinion, that the practice of numbering Lodges while under dispensation, ought to be discontinued. We would also call your attention to a resolution offered by Brother W. D. Goff, recommending the calling of a convention of Grand Lodges, &c., &c.,

which was, however, indefinitely postponed. [See page 15.]

Also, to the report of the Committee of Foreign Correspondence, [page 19,] with reference to settlement of dues, and of the establishment of a Grand Lodge for the State of Louisiana; and to the report of the Committee on Grand Master's communication, and the resolutious thereunto annexed. In the opinion of your committee, the practice spoken of is a just cause of complaint.

The M. W. N. G. Lodge was called to labor at 9 o'clock.

M. W. Brother Paul Drayton, N. G Master, presiding. Other officers in their respective stations.

The minutes of the afternoon session of yesterday were read, and on

motion, approved.

M.W. Brother R. H. Gleaves having been accepted as the representative of the M. W. G. Lodge for the State of Ohio, was appointed on the Committee of Condolence.

The committee appointed on the M. W. N. G. Master's address, submitted the following report, viz.:

To the Officers, Representatives and Members of the M. W. N. G. Lodge of Free and Accepted A. Y. M., of the United States of North America, and the Masonic jurisdiction thereunto belonging:

We, your committee, to whom was referred the Address of the M.W. N. G Master, respectfully submit the following for your consideration:

1st. We recommend the approval of the reasons assigned by the M.W.N.G. Master, for convening the M.W.N.G. Lodge in the City of Baltimore, State of Maryland, instead of the City of Boston, State of Massachusetts, as per vote of the M.W.N.G. Lodge, Ootober, A. L. 5862, believing that the change has conduced to the best interest of the Fraternity.

2d. We deem it unnecessary to consider that part of the address which refers to the establishment of Lodges in the States of North and

South Carolina, the subject having already been considered by the

M.W. N. Grand Lodge.

3d. With regard to that part of the address which refers to the necessity of a uniformity of work throughout our jurisdiction, we recommend that an expert and judicious committee be appointed, who shall be charged with the duty of arranging and preparing the work of the Order in such a manner as in their judgment shall be conducive to the best interest of the Craft, and report the same to the next Triennial Session of this M.W. N G. Lodge.

4th, That portion which relates to Military Lodges: we respectfully recommend the adoption of the following regulations, for the government of any and all such Lodges as may be warranted or chartered by any M.W. Grand Lodge under the jurisdiction of this M.W. N. G.

Lodge.

REGULATIONS OF MILITARY LODGES.

It being essential to the interests of the Craft, that all military Lodges should be strictly confined to the purposes for which their warrants were originally obtained, and as very great abuse may arise from the improper initiation of Masons by such Lodges, every warrant, therefore, which is held by a military Lodge, shall be forfeited, unless the following laws be complied with, in addition to those specified under the rule regulating subordinate Lodges.

1st. No warrant shall be granted for the establishment of a military Lodge, without the consent of the commanding officer of the regiment, battallion or company, to which it is to be attached, having been first obtained.

2d. No military Lodge shall, on any pretence, initiate into Masonry, any inhabitant or sojourner at any town or place at which its members may be stationed, or through which they may be marching, or any person who does not, at the time, belong to the military profession, nor any military person below the rank of a corporal, except as serving brethren or by dispensation from the Grand Master.

3d. When any military Lodge under the Constitution of a M.W. G. Lodge, under the jurisdiction of this M.W. N. G. Lodge, shall be in foreign parts, it shall conduct itself so as not to give offence to the Masonic authority of the country or place in which it may sojourn, never losing sight of the duties it owes to the Grand Lodge, to which communication is ever to be made, and all fees and dues regularly transmitted.

4th. If the regiment, battallion, or military company to which a military Lodge is attached, be disbanded or reduced, the brethren shall take care that the warrant be carefully transmitted to the Grand Lodge, that it may not fall into improper hands; but if a competent number of the brethren remain together, they may apply for another warrant, of the same number, to be holden as a civil Lodge, at such place as may be convenient, and which may be approved by the Grand Master. Such warrant to be granted without any additional expense.

Your committee deem it inexpedient to consider that part of the address which refers to the recognition of this M.W. N. G. Lodge by the Grand Orient of Haiti, that part of it having already been submitted to the Committee on Foreign Correspondence, but that part of the address referring to the visitation of the Brother of high standing in the Fraternity of the Republic of Haiti, who visited the M. W. G. Lodges for the States of New York and Pennsylvania, and who was made the subject of special consideration by the aforementioned Grand Lodges, we have been favored with the loan of the following papers and official documents, and their translation. [See Appendix.]

6th. Document dated Port au Prince, Dec. 11, 1864, to M. W. Grand Master, Paul Drayton, signed, Fenelon Duplesses, recommending certain brothers to be appointed Representatives in Lodges numbered

5, 22 and 24, at Port au Prince, Haiti.

7th Document from M. W. Brother Wm. Darnes, P. N. G. Master.

8th A petition from the Baltimore Publishing Company to the M.W. N. G. Lodge; which petition the committee report back for final action thereon. Petition signed, James W. Hill, President of the Baltimore Publishing Company.

Your committee recommend to this M.W. N. G. Lodge the necessity of recognizing the fraternal sentiments enunciated in the documents received from our distinguished correspondent from the Orients of Haiti and of France.

We further recommend that the documents numbered one to six be placed in the hands of the Publishing Committee, to be printed with the minutes of this Triennial Session, and that the officers of this M W. ADDRESS

OF THE

M. W. N. G. MASTER.

Brethren of the Most Worshipful National Grand Lodge of the United States of America, greeting:

We would recommend, brethren, that you make ample provision for the publication of the Minutes and Constitution submitted by the Committee, so as to enable us, at an early day, to present them to the craft for their information.

Brethren, we would further say to you, that we shall strive to deserve your respect, and we do assure you that you shall always have undivided friendship and a brother's love. In full accordance with the rules and usages of Ancient York Masonry, we will endeavor to govern this M.W.N. G. Lodge with calmness, firmness, and impartiality, with a watchful eye to the rules, regulations and Constitution of this M.W. N. G. Lodge, and Masonry in general.

Brother Officers, we are about to enter upon new duties; let us, as Masons, use our utmost exertions to agree in private council, ever being mindful that we are to assist each other in carrying out the true principles of the Order, and in the full performance of our several duties. Much will depend upon our actions. Let us, as the heads of the Masonic family, set good examples.

And now, brethren, our labors are almost finished for the session, and we will soon separate from each other; and who knows, perhaps, for many of us, we have met for the last time upon earth in a Masonic convocation. Therefore, let each one carry home with him those true Masonic principles—Truth, Friendship, and Brotherly Love. And further may we all go to our several places of abode with the full determination of defending the interests of the M.W. N.G. Lodge, to which we all claim membership.

In conclusion, brethren, we would ask the blessing of the Great Architect of the Universe to rest and abide with us all, forever; and may we be so blessed as to meet, after time, in the Grand Lodge above—a house not made with hands, eternal in the heavens.

DOCUMENTS REPORTED BY THE COMMITTEE ON THE M. W. N. GRAND MASTER'S ADDRESS.

PORT AU PRINCE, July 20th, 1864.

Paul Drayton, Esq., Brooklyn, N. Y.:

M. W. Brother:—I simply drop you a line at this time to say that the Grand Orient of Haiti, at its semi-annual session, this month, took final action on its relations with the National Grand Lodge of the United States; and confirmed the action taken by its Council of Administration last year in this respect, namely: a full and perfect recognition of the Masonic standing of the National Grand Lodge has been accorded by the Grand Orient, after a mature deliberation of more than

one year on the claims of the same.

The last paper I addressed to the Grand Secretary, detailing a history of the Masonic difficulties between the National and the United Grand Lodge, and showing the respective origin of each, has cast the balance in favor of the National, and brought about this decision. The Grand Secretary told me yesterday that he is so pressed at present that he could not write me the official papers on the subject, but will do so as soon as possible. Meanwhile he gave me the official information in person, so that I might at once communicate it to you. As a vessel leaves here to-night, I lose no time in sending you word.

Mrs. Holly joins me in love to yourself and lady. Please remember me fraternally to all the brethren; particularly to the Visiting Brother,

Fenelon Duplessis, if he should be still among you.

Mr. Jonathan Davis, Grand Master of the Grand Lodge for Pennsylvania, Orient of Philadelphia:

ILLUSTRIOUS BROTHER AND FRIEND:—It is already three months since I have quitted the United States, and since then I have not received from you any news. Permit me to testify to you my regret for it, and to tell you all the pleasure which I shall have in holding with you, and the Grand Lodge which you preside over, a communication coherent and regular. The brilliant and cordial welcome which I have received from the Masons of Philadelphia has left in my heart

a grateful remembrance, which will not be effaced. I have not missed to mention to my Lodge, and in general to tell the Fraternity of Haiti the cares and kindness of which I have been the object on the part of the Grand Lodge and of the Grand Council of 33d. My recital has produced a lively emotion, and I am authorized to say to you that these two Grand and Illustrious bodies count hereafter, in Haiti, only as brothers and as friends, sincere and devoted. You will find the proof of this in the resolutions which have been passed by our Lodge, and of which I send you herewith the documents relative to them. I am profoundly happy to have contributed to open some relations between your Grand Lodge and the Lodge to which I belong; I nourish the hope that I shall have the felicity to extend these relations to all the other Lodges of the country. Before quitting New York, I despatched to you a seal, which I prayed you to make accepted by the Grand and Supreme Council of 33: as a testimony of my gratitude and of my attachment. Make me to know if you have already had occasion to present it to the Supreme Council.

I make you to know, meanwhile, that the Grand Orient of Haiti has accepted the overtures of alliance which the National Grand Lodge had made to it, through the mediation of Brother, dear Brother, Holly.

These two Grand bodies are to-day in perfect relation of friendship, and as your Grand Lodge takes origin from the National Grand Lodge, it necessarily follows that the alliance between the two Grand bodies extends down to you. It is in virtue of this that the Worshipful Lodge, the Friendship of the United Brethren, No. 1, has been able, on my proposition, to tender to you a fraternal hand, and to decorate with a title of honor a Grand Mason of your Orient, the powerful Brother, Wm. H. Riley.

The Grand Orient of Haiti has two sessions a year, one in January and the other in July. When I had returned here, already the session of July was closed. I am obliged to wait until January to present the

communication of which I am the bearer on your part.

I hope that they will be favorably received, since I have just told

you the principle of the alliance is already adopted.

My very dear and powerful Brother, in a reunion of your Grand Lodge, which I pray you to convoke expressly, give knowledge to the craft of this letter, and of the documents which accompany it. Pray all the brothers to accept the project of union which these documents bring, and tell them that their remembrance is in my heart.

To respond to your nomination as our representative to your Grand Lodge, this one will wish, without doubt, (and I engage strongly to do it) to create a representative in our bosom. I propose you to name to this office the Brother Charles Archin, Master of the Worshipful, The Friendship No. 1. This will be a choice worthy of the

two Lodges.

If my proposition is accepted, address to me directly, your letters to the address of the Lodge and of Brother Archin. By the next mail I will write to you to propose to you some overtures of alliance with the

other Lodges of Port au Prince.

I have promised to bind the union between the Masons of the Orients; I will make, to arrive at this end, all my efforts.

Let us follow in common the work of the fraternity, and may the Grand Architect of the Universe bless our labors.

In my letter of the 7th of November, I was testifying to you my desire to see the Grand Lodge which you preside over enter into correspondence, not only with mine, but also with the three other Lodges of Port au Prince. I make sincere prayers for the prosperity of the labors of the Grand Lodge, and for the happiness of all its workmen. Receive my wishes on the occasion of the new year. (Extract from the Minutes of the session of August 30, 1864.)

The Worshipful inquired whether any brother had anything to offer for the good of this Lodge in particular, or of the Order in general, when Brother Fenelon Duplessis, Past Worshipful, recounted some of the circumstances of his travels in the United States. He spoke gratefully of the fraternal reception he had received from the Masons of our race in New York and Philadelphia. No brother of the Fraternity ever found upon a strange shore more sympathy, cordial attention or delicate care, bestowed with greater kindness or earnestness. Their

kindness was above all expression. Every Lodge I visited was anxious to take upon themselves the expenses of my sojourn in America. They also conferred upon me the degrees I wished. In brief, my travelling expenses, though not small, yet they insisted on paying them; I had not once to open my purse. Notwithstanding the scruples which caused me to hesitate, they pressed with such delicacy, that I was at last obliged to accept their courtesies.

After my brilliant reception in New York, a deputation of Brothers conducted me to Philadelphia, where I was attended with all honor and good will. The Grand Master, Jonathan Davis, and the Grand Commander, Wm H. Riley, received me most honorably. The Sublime Council of 33d were right willing to confer upon me the last degree of the Order, and have made me an honorary member of their Sovereign Workshop. After a brilliant reception given to me by the Grand Lodge, where many Grand Masters were present from other States and assisted, I was made their Representative in the Grand Orient of Haiti.

I wish, dear brothers, that you may have a part of the distinction which I have received; you are entitled to all the honor, for all good Masons of Haiti have been saluted and honored in me.

To give to our Philadelphia brothers a testimony of our affection, I

now propose,

1st. To make overtures of alliance and fraternal correspondence to the Grand Lodge for Pennsylvania East, at Philadelphia.

2d. To constitute the Most Worshipful Grand Master Jonathan

Davis our Representative in their Grand Lodge.

3d. To proclaim the Grand Eminent Commander, Wm. H. Riley, an honorary member of our Respectable Workshop.

Most Worshipful Sir and Brother:—On the receipt of your last communication, indicating your willingness to receive a direct communication from the Grand Secretary of the Grand Orient of Haiti, touching the matter of fraternal recognition, I communicated that fact to the Grand Secretary, the Most Illustrious Brother, Eugene Bourjolly, 33d, and informed him also of your expressed determination to convoke an extraordinary session of the National Grand Lodge over which you preside, as soon as his official communication in behalf of the Grand Orient of Haiti shall reach your hands. Finally, I apprised him of a "direct occasion" to write by the steamer "City of Port au Prince," to sail from here to-morrow, the 19th, as he had requested me to do in his official communication of September 8th, ult., a translation of which, with my official certificate appended, I herewith send enclosed. Moreover, I invited him to place his communication in my hands, and I would charge myself with sending it to its destination.

In pursuance of this information, given to the Grand Secretary, I called on the Illustrious Brother at High Twelve this day for his response, and I found him busily engaged in drawing up the communication. The rough draft thereof, in pencil marks, was finished, and he obliged me by reading the same in my hearing. It is truly a soulstirring document, recalling us to the fundamental principles of Masonry, and awakening patriotic sentiments of race within our bosoms.

As I will not receive the finished copy until it is time to mail all my letters by the steamer, I shall not be able to make even a hasty copy thereof. And as the copy of so important a document should be in this Masonic Legation, on file among its precious archives, I pray you, therefore, Most Worshipful Grand Master, send me a copy per return of steamer, in the original French. Hoping that the negotiation in which I have been engaged for the past eighteen months and more has now been brought to a satisfactory result to you and the National Grand Lodge over which you preside, I shall continue hereafter, as heretofore, to labor for the glory, the unity, and the fraternal fusion of all true men and Masons.

Having taken into serious consideration the fraternal overtures made by the Illustrious Grand Master, Paul Drayton, and the Most Worshipful Brother, Grand Secretary Edward M. Thomas, who, we regret, is since deceased, the Grand Orient of Haiti, in its wisdom, has resolved to open an active and friendly correspondence with your National Grand Lodge, which cannot fail to bring us nearer to the object towards which our efforts are directed, viz: Peace, Concord and Fraternity, which, alone, as you know better than myself. Most Worshipful Brothers, can guarantee the happiness of all the members of the great human family. It is, therefore, with lively interest that the Haytian Grand Orient accedes to the wish which you express, of forming those intimate relations which will consolidate a people of friends and and brothers, united, moreover, by the ties of consanguinity. Let us, then, labor without cessation for our moral advancement and our intellectual emancipation, by rallying with all our hearts under the banner of Fraternity.

Among them you will likewise find one from the Sovereign Chapter of Knights Templars, by which you have been created an honorary member of its body. Before I was Worshipful of the Lodge, I had presided in the Chapter: it is from this that I reserved to myself the honor of inscribing your name upon its column. My happiness is great in bearing witness to my brothers of America, of my affection and gratitude in advance of the report of friendship between them and the Lodge from which I received the light of Masonry. The reception they gave me, and the kindness with which they received me, have left a profound impression in my heart, and I will employ all my efforts, as I have solemnly promised to do, to bring together the two branches of the Masonic Order. this for me to all my brothers. I am specially happy in giving you, personally, the proof of my remembrance of you; believe that you have in me a brother and a friend. In concert with him I will work to secure the chain in the union between

these three Lodges and yours. The three Lodges are,

The Star of Haiti, No. 5; Mount Liban, No. 22; United Hearts, No. 24. I propose, as Representative of the Grand Lodge for the State of New York,

For No. 5, Brother Fleury Battur;

For No. 22, Brother Joseph A. Courtois; For No. 24, Brother Chereman Cheri.

I have no doubt, my dear Brother, of the promptness with which you will present to the Grand Lodge the different documents, and your care to secure their success. That us two should be in unison, is the end for which I call you to follow with me with the greatest vigor.



1st. That the banner of the Lodge shall be draped in crape, in sign of mourning, for three months.

2d. That the members of the Lodge shall wear crape on their hats for the same time.

3d. That an address of condolence and sympathy be sent to the Grand Lodge of the State of New York, to that of the State of Illinois, and to the Grand Lodge of the Brothers of Color of the State of New York.

In virtue of this last resolution, the Lodge has unanimously voted the following fraternal address, which we basten to remit to you.

The Lodge Renaissance has felt, like you, as much as you, the blow which has struck you.

We weep with you, in Abraham Lincoln, the worthy Mason and the true citizen.

Lincoln is henceforth a grand figure in history. He is one of the

purest and most beautiful personifications of Democracy.

He has achieved three great things: he has co-operated in the strengthening of the Union; in the abolition of slavery; and he has known how, in employing force, to use it prejudice to right and liberty. And all this without parade, modestly, simply.

He had three qualities which are rarely seen united in the same man; a strict sense of equity, energy to defend it, and unchangeable good-

ness.

His last moments were an appeal for concord, for peace, for fraternity with the vanquished rebels; his last deed was the declaration of the political rights of the liberated negroes.

True citizen, he has not been less worthy Mason; his life is a reali-

zation of our symbols.

As Apprentice, he had purged his soul of all the subversive passions, preparatory condition of good morals, that which indicates our three journeys.

As Companion, he had learned to submit himself to order, and to observe scrupulously right and justice, that which is symbolized so well

by the Rule, the Square, the Compass, and the Trowel.

Like Hiram, finally, he has succumbed under the blow of unbridled

pride, for having remained inflexible in duty.

Full of honor and loyalty, like Washington; passionate lover of liberty, like Jefferson: Lincoln has consolidated the structure these great citizens founded, the stones of this universal confederation.

But he has done more; he has confirmed in the soul the ideal of Democracy, seconded in this work, it is necessary to say, by the entire

American people.

This last thought has mitigated, some little, the bitterness of our

regrets.

For, however deplorable this loss may have been, our confidence in the future has not been one instant disturbed.

The people who govern themselves are raised above ruin from the death of one man.

No humiliating terror reigns among them! Nothing can overturn

a social edifice which right cements from roof to foundation.

Lincoln will remain one of our best models. This grandeur in simplicity ought not to die. It must be that his memory will remain always in our souls, and that in our temples and out of our temples it

will be sterile. Let us labor, like him, to abolish slavery, to model all institutions in accordance with justice, always reverencing liberty.

DECLARATION OF SENTIMENT.

OF THE

GREAT NATIONAL CONVENTION,

HELD IN THE CITY OF BOSTON, STATE OF MASSACHUSETTS, ON THE 24TH, 25TH, 26TH AND 28TH DAYS OF JUNE, A. L. 5847.—A. D. 1847.

SENTIMENT 1. The question has been asked, the cause of the separate organizations of white and colored Masons in the United States of America. We do not know of any good reason why there should be, and we have made several attempts, without any success, to have but one. We are, and always have been, in possession of all the ancient landmarks and regulations of the Craft; and we do acknowledge all genuine Masons, of all nations and shades of complexion, to be our brethren.

SENTIMENT 2. Therefore, in pursuance of the above call, we have met in the City of Boston, State of Massachusetts, in the year and date above mentioned, and do form in convention, and lay before the world our sentiments thereon.

SENTIMENT 3. In all stages of oppression, we have petitioned for redress, but found none; therefore, in solemn convention assembled, we do, in the name of the Great Masonic Body of Free and Accepted A. Y. Masons, declare ourselves a free and independent body of Masons, to be known as the National Grand Lodge of Free and Accepted Ancient York Masons, (Colored,) of the United States of America, and Masonic jurisdiction thereunto belonging, with full power and authority to grant warrants of constitution to all State Grand Lodges

under our jurisdiction, and that the said State Grand Lodges shall have full power and authority to grant letters of dispensation and warrants of constitution to subordinate Lodges within their several jurisdictions, and to establish as many Lodges as they may deem most expedient.

SENTIMENT 4. Not that we have been wanting in attention to our white brethren, we have from time to time solicited them to extend their jurisdiction over us, but to no effect.

We, therefore, the delegates of the several Lodges throughout these United States, in convention assembled, appealing to the Supreme Judge of the World for the rectitude of our intentions, do, in the name, and by the authority of our constituents, declare and publish the said National Grand Lodge, (Colored,) of the United States to be a Free and Independent body, with full powers, as named in the third article of this declaration; and for the support of this declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge ourselves to each other in the solemn ties of Brotherhood.

Your committee most respectfully recommend to your honorable body, the Free Mason's Library and General Ahiman's Rezon, as published by Samuel Cole, second edition, published in 1826, for your government for the next ensuing six months, or the time being, and that the eighth article of the eighth section shall in no case or instance be departed from.

CONSTITUTION

OF THE

MOST WORSHIPFUL

NATIONAL GRAND LODGE

OF THE

UNITED STATES OF NORTH AMERICA.

ARTICLE I.

NAME, STYLE, AND JURISDICTION.

SEC. 1. This Grand Lodge shall be known and called by the name of "The Most Worshipful National Grand Lodge of Free and Accepted Ancient York Masons of the United States of North America;" And it is hereby declared to be the highest legitimate source of Masonic authority (colored) of and over the three Symbolic Degrees of Free Masonry within its jurisdiction; and of right "guaranteed to it by resolution adopted by the Delegates in Convention assembled, June 26th, A. L. 5847, A. D. 1847;" exercises jurisdiction and government over all Symbolic Grand Lodges (colored) within the United States of North America. And no such M. W. Grand Lodge can exist or exercise any Masonic privileges or duty, within the United States, without the sanction of this M. W. N. Grand Lodge, by warrant duly granted for that purpose. And all convocations or assemblies of persons calling themselves Lodges of Free Masons, in any of said States, of either or all of the three Symbolic Degrees, without the sanction of this M. W. N. Grand Lodge first had or obtained, are hereby declared to be spurious and clandestine, and of no Masonic authority whatever.

ARTICLE II.

THE GOVERNMENT, POWERS, AND PRIVILEGES.

The governmental powers of the M. W. N. Grand Lodge are:

1st. Executive.

2d. Legislative.

3d. Judicial.

The exercise of these powers and privileges is defined in the Constitution and General Regulations, which it has an inalienable right to frame and adopt at its own convenience, and alter, amend, add to, or repeal, at its pleasure, under the limitations therein imposed; and are

final and conclusive upon all parties concerned, until altered or reversed by the M. W. N. Grand Lodge. But nothing can be adopted in derogation of the ancient landmarks, nor can any legislative act or general regulation be passed affecting the interest of the whole Fraternity, except at a stated Triennial Communication of the M. W. N. Grand Lodge. These powers and privileges are supreme and exclusive within its jurisdiction, over all that appertains to Ancient Craft Masonry.

1st. All the executive powers of the M. W. N. Grand Lodge, when

not in session, are reposed in the National Grand Master.

2d. The legislative powers of the M. W. N. Grand Lodge extends to every case of legislation not delegated or reserved to M. W. Grand Lodges.

3d. The judicial powers of the M. W. N. Grand Lodge are of two

kinds:

1st. Original—embracing all matters of controversy which may arise between any of the M. W. Grand Lodges under its jurisdiction, or the members of different Grand Lodges, and the enforcement of discipline upon its own members, and the M. W. Grand Lodges under its jurisdiction, and upon individual Masons; and

2d. Appellate—embracing all matters of controversy and discipline proper for Masonic investigation, arising in any M. W. Grand Lodge,

and over which it has not original jurisdiction.

All governmental powers, whether executive, legislative or judicial, not expressly delegated by the M. W. N. Lodge, are inherent and reserved to it, as the supreme governing body.

ARTICLE III.

MEMBERSHIP.

SEC. 1. The Most Worshipful National Grand Lodge is composed of its original members, together with those appointed to office at the Triennial Session held A. L. 5850, A. D. 1850, of its Grand and Past Grand Officers, and likewise of the several Grand and Deputy Grand Masters, Grand Wardens, Treasurers and Secretaries, or their proxies, shall be the only members and voters in the M. W. N. Grand Lodge.

SEC. 2. No one shall be the proxy of the Grand Master except a Grand or Past Grand Master, and no one shall be the proxy of a Past Grand Master except a Grand or Past Grand Master, who may be appointed from any other jurisdiction. A proxy appointed to represent any other officer of a M. W. Grand Lodge must be a Past Officer of the same grade, and a member of the jurisdiction where appointed.

SEC. 3. Each member shall be entitled to one vote, and each M. W. Grand Lodge for a State shall be entitled to six votes, regardless of

the number of its representatives which may be present.

SEC. 4. The representatives of a M. W. Grand Lodge for a State are its M. W. Grand Master, R. W. Deputy Grand Master, R. W. Grand Senior Warden, R. W. Grand Junior Warden, R. W. Grand Treasurer, and R. W. Grand Secretary.

ARTICLE IV.

NATIONAL GRAND OFFICERS.

SEC. 1. The officers of the M. W. N. Grand Lodge are elected or appointed, and shall hold their office for three years, or until their successors are chosen and installed.

SEC. 2. The elective officers of the M. W. N. Grand Lodge are: the M. W. N. Grand Master, M. W. N. Deputy Grand Master, M. W. N. Grand Senior Warden, M. W. N. Grand Junior Warden, M. W. N.

Grand Treasurer, and the M. W. N. Grand Secretary.

SEC. 3. The appointed officers are the M. W. N. Grand Chaplains, a N. Grand Marshal, a N. Grand Sword Bearer, a N. Grand Senior Deacon, a N. Grand Junior Deacon, a N. Grand Senior Steward, a N. Grand Junior Steward, a N. Grand Pursuivant, and a N. Grand Tyler.

The rank of the officers, both elective and appointed, is in the order

here mentioned.

ARTICLE .V.

The communications of the M. W. N. Grand Lodge shall be held tri-annually on the first Monday of October, at such place as may be designated by a vote of its members and representatives.

. Special communications may be had upon the concurrent petition of

five M. W. State Grand Lodges, parties to the national compact.

ARTICLE VI.

SEC. 1. Elective officers of the M. W. N. Grand Lodge must be chosen at each Triennial Session, by ballot, (unless it be unanimously resolved at the time to take a vote by show of hands,) and a majority of the whole number of votes given is necessary for a choice. But if, on the first ballot, no choice be made, a second shall be had, confined, where the votes are equal, to the two highest on the return; and where there are three or more candidates, and one having a plurality of votes, and two or more an equal number of votes, then confined to such candidates; and where the votes are equal, to those having an equal number of votes. If, on the second ballot, there be no election, the contest between the candidates being in either of the above predicaments, shall be determined by lot.

SEC. 2. The officers so elected are to be installed into their office as soon after the election as possible, to whom shall be delivered the effects of the M. W. N. Grand Lodge; and vacancies may be filled by temporary appointments from the National Grand Master, till the next triennial election, having reference to the fitness of the brethren selected.

ARTICLE VII.

Each M. W. Grand Lodge holden under the authority of this M. W. N. G. Lodge, shall be required to make, or cause to be made to the National Grand Secretary, a regular return of the list of the Lodges under its jurisdiction, and of the number of members belonging to each Lodge, and of the resignations, suspensions, expulsions, deaths, and of the reinstatements of members suspended or expelled; with the pay-

ment of an annual tax of 6½ cents on each member in standing, under its jurisdiction, which sum shall be appropriated to defray the expenses of the M.W. N. Grand Lodge. Such returns and such payments to be made annually.

ARTICLE VIII.

The M. W. N. Grand Lodge shall have power to meet in any town, city, village or State within the United States, and to summon any of its officers or members to attend with any books, papers or other matters that may be in their possession, being the property of the M.W.N. Grand Lodge.

ARTICLE IX.

The revenue of the M.W. N. Grand Lodge shall be derived from the following sources:

1st. For every warrant or charter for a M. W. Grand Lodge for a

State, \$50.

2d. For each member in standing, under the jurisdiction of a M. W.

State Grand Lodge, 61 cents.

Each M.W. Grand Lodge shall be accountable for the dues of each of its subordinate Lodges embraced in its returns, except such as are exempt by the constitution or the by-laws of its subordinate Lodges.

ARTICLE X.

In the computation of time, relative to salaries of the Elective National Grand Officers, the year shall be considered as commencing and terminating on the day of election and installation, and such salaries to be paid at the close of each triennial session, accordingly.

ARTICLE XI.

SEC. 1. One representative from each Grand Lodge for a State shall be entitled to receive their travelling expenses, at the rates established by the proprietors of public conveyances which shall be taken in coming directly from their Grand Lodge to the place of meeting, and returning thereto, as charged by said proprietors at the time. And though he or they may represent more than one M. W. G. Lodge, he or they shall receive pay only for one Grand Lodge. Nor shall they receive more than the aggregate dues of the Grand Lodge or Grand Lodges they shall represent.

SEC. 2. The Elective National Grand Officers shall be entitled to like compensation from the funds of the N. G. Lodge. Absence of a N. G. officer or representative, before the close of the communication, or from any cause, except sickness of or calamity to himself or his family, shall forfeit all claims to payment or compensation under this provision.

ARTICLE XII.

OF POWERS OF OFFICERS.

SEC. 2. The N. G. Master has power:

1st. To convene or order to be convened, any M. W. G. Lodge for a

State within the jurisdiction, to preside therein, to inspect their proceedings, and require their conformity to Masonic rules.

2d. To require the attendance of and information from any National

Grand officer, respecting his office.

3d. To order warrants for organizing new Grand Lodges, on proper

application, when the M.W. N. G. Lodge is not in session.

4th. To appoint representatives, by warrant, in foreign Grand Lodges, and receive and accredit such representatives from foreign Grand Lodges.

5th. When the National Grand Lodge is not in session, he may ex-

ercise all its executive functions.

SEC. 2. In case of the death, absence, or inability of the National Garnd Master, or a vacancy in his office, the National Deputy Grand Master, National Grand Senior Warden, and National Grand Junior Warden, will, in succession, succeed to his prerogatives and duties, for all purposes.

SEC. 3 No Past National Officer has any power or privileges as such, except the respect due to standing, skill and experience, save what is expressly given him by the Constitution of the National Grand

Lodge.

ARTICLE XIII.

DUTIES OF OFFICERS.

It shall be the duty of the M.W N. Grand Master:

1st. To preside in the National Grand Lodge at its communica-

tions; and,

2d. To discharge all the executive functions of the National Grand Lodge, in the interval between its sessions, except as otherwise provided. It shall be the duty of the National Grand Wardens,

1st. To assist in the affairs of the National Grand Lodge; and,

2d. To diligently preserve the ancient landmarks throughout the jurisdiction.

It shall be the duty of the N. Grand Secretary:

1st. To record the transactions of the N. Grand Lodge.

2d. To receive, duly file, and safely keep all papers and documents, and seal of the National Grand Lodge.

3d. To sign and certify all instruments from the National Grand

Lodge or N. G. Master.

4th. To receive and keep a proper account of all moneys of the National Grand Lodge, and pay over the same, without delay, to the National Grand Treasurer.

3th. To report, triennially, to the National Grand Lodge, the amount of moneys received by him, by items, and the specific source from which it was received; also, the Grand Lodges that have neglected to render proper returns of their elections, Lodges, and dues, and such general information as to the state of the Grand Lodges as may be proper for the information or action of the National Grand Lodge.

6th. To conduct the correspondence of the National Grand Lodge,

under the direction of the National Grand Master, and in a Masonic manner.

7th. To attend, with all necessary writings, under his control, all meetings of the National Grand Lodge, on the requisitions of the Acting N. G. Master, and also to attend upon the N. G. Master on Masonic business, when required.

8th. To issue summons to attend the sessions of the M. W. N.

Grand Lodge.

9th. To receive all petitions and memorials intended for the National Grand Lodge, and to lay them before the National Grand Master, or

other authority.

10th. To keep a register of all warrants or charters granted by the N. Grand Lodge; of the returns from the Grand Lodges, and of the suspensions, expulsions and rejections which may be returned from the several State Grand Lodges.

It shall be the duty of the N. G. Treasurer:

1st. To take charge of all the funds, property, securities and vouchers of the National Grand Lodge.

2d. To pay all orders duly drawn under general regulations or spe-

cial directions of the N. G. Lodge.

3d. To attend on the N. G. Lodge or its presiding officer, when required, with the books and all necessary documents relating to his office; and, when required; the meeting of any committee whose duty it may be to act in relation to fiscal concerns of the N. G. Lodge.

4th. To report, triennially, to the N. G. Lodge the amount of receipts and expenditures, by items, and from whom received, and to whom paid, and the amount of securities in his hands for funds invested.

5th. To execute and file with the N. G. Secretary an official bond, with sureties, to be approved by the N. G. Master, or N. D. G. Master, conditioned that he will pay or deliver, on demand, to the N. G. Lodge, or to his successor in office, all funds and property of the N. G. Lodge that shall come to his hands as National Grand Treasurer.

6th. To pay and deliver, at the expiration of his term, to his successor in office, or such person as shall be designated by the N. G. Lodges, all monies, securities, evidences of debt, books, writings, and property of the N. G. Lodge under his control, with all proper assignments when necessary.

It shall be the duty of the National Grand Chaplains to attend the N. G. Lodge, and to perform the religious services.

It shall be the duty of the National Grand Marshal:

1st. To proclaim the National Grand Officers at their installation.

2d. To introduce the Representatives of foreign Grand Lodges, and visiting brethren of distinction; and

3d. To conduct the processions of the National Grand Lodge. It shall be the duty of the National Grand Sword Bearer:

1st. To carry the sword in procession; and

2d. To perform such other duties as, by ancient usage, pertains to his office.

It shall be the duty of the National Grand Deacons to assist within

the body of the National Grand Lodge, in such duties as, by usage, appertain to their office.

It shall be the duty of the National Grand Stewards:

1st. To have the immediate superintendence in provisions to be made for festivals, and

2d. To perform the duties prescribed in this Constitution. It shall be the duty of the National Grand Pursuivant:

1st. To communicate with the National Grand Tyler, and announce all applicants for admission by their names, Masonic address, and connection; and

2d. To take charge of the regalia, under the directions of the Na-

tional Grand Officers; and

3d. To attend all meetings of the National Grand Lodge, and at other times, upon the requisition of the N. G. Master, or other presiding officer.

It shall be the duty of the National Grand Tyler:

1st. To guard the door of the National Grand Lodge on the outside, to report all persons claiming admission, and to see that none enter but such as may be duly authorized and properly clothed

2d. To perform all the customary services pertaining to his office;

and

3d. To attend all meetings of the National Grand Lodge, and at other times, upon the requisition of the National Grand Master or presiding officer.

The National Grand Tyler must be a Past Master Mason, but shall

have no vote during his continuance in office.

It shall be the duty of the several officers of the National Grand Lodge, in addition to the duties herein specifically mentioned, to perform such other duties appertaining to their office, as shall from time to time be directed by the N. G. Lodge.

The National Grand Secretary and National Grand Tyler shall each receive such stated compensation for their services as the National Grand Lodge shall direct, which shall not be altered at any time so as

to affect the incumbent in office.

ARTICLE XIV.

OF SUCCESSION.

In all cases of the absence of any officer of this M. W. N. Grand Lodge, the officer next in rank shall succeed his superior, unless, through courtesy, said officer should decline in favor of a Past superior officer present. And in case of the absence of all the officers from any legal meeting, the members present, according to seniority and ability, shall fill the several offices.

ARTICLE XV.

COMMITTEE OF FINANCE.

The Committee of Finance is composed of five members. They are required to report to the National Grand Lodge, on the second day of each Triennial Session, an estimate of the probable disbursements for

the ensuing term, with a statement of the sinking fund, and the debts due to and by the National Grand Lodge, and such other matters as may be necessary to a correct view of its finances.

It is their duty to recommend to the N.G. Lodge, from time to time, such measures as they may deem expedient for collection of its dues,

the economy of its funds, and increase of its revenue.

The Committee may, at all times, have access to the books and papers of the N. G. Secretary, N. G. Treasurer, and other officers or committees intrusted with moneys of the N. G. Lodge. And such officers and committees are to account with the Committee of Finance at each Triennial Session of the N. G. Lodge.

All matters relating to the finances of the N. G. Lodge are referred to the Committee, and they are to make report thereon, unless other-

wise directed by the N. G. Lodge.

ARTICLE XVI.

COMMITTEE OF CORRESPONDENCE.

The Committee of Correspondence shall consist of three members, to whom shall be referred all communications made to the National Grand Lodge on such subjects, requiring special consideration, as the N.G. Lodge may deem proper to submit to them. This committee must report all its proceedings for the approbation of the N.G. Lodge.

GENERAL REGULATIONS.

ARTICLE I.

Every officer and member of the National Grand Lodge must be a member of a subordinate Lodge within the jurisdiction of the National Grand Lodge.

ARTICLE II.

No brother, resident in the vicinity of a Lodge, and who is not a member of some Lodge, shall be permitted to visit the National Grand Lodge, except by special invitation.

ARTICLE III.

When a duty is imposed, its neglect or violation without excuse, shall be considered an offence against Masonic law.

ARTICLE IV.

The representatives of five Grand Lodges, convened on due notice, shall be indispensably necessary to open or transact business in the National Grand Lodge, except on occasions of ceremony, when the National Grand Master or his Representative, with a sufficient number

of brethren being present, the National Grand Lodge may be opened for the transaction of the business for which it is called.

ARTICLE V.

The accounts of the National Grand Treasurer and National Grand Secretary shall be examined, and the items compared with the vouchers, triennially, by a discreet committee, to consist of three members appointed for that purpose.

ARTICLE VI.

None but members of the National Grand Lodge, (brothers of distinction from other jurisdictions excepted,) shall be present at the opening of the same, nor during an election.

ARTICLE VII.

Absence of a National Grand Officer, or either of the Representatives from a Grand Lodge (who are entitled to pay,) before the close of the session, or from any cause, except sickness of or calamity to himself or to his family, shall forfeit all claim to payment or compensation.

ARTICLE VIII.

SEC. 1. The National Grand Secretary shall be paid the sum of dollars per annum for his services as such, and for writing Grand Lodge charter or warrant, each \$

SEC. 2. The National Grand Tyler shall be paid the sum of one dollar and fifty cents for every day he tyles for the National Grand Lodge.

ARTICLE IX.

All Free Masons who are acknowledged as such by any of the Lodges in good standing (as M.Ms.) under the jurisdiction of Grand Lodges in fellowship with this National Grand Lodge, may be admitted as visiting brethren, under the restrictions imposed by this Constitution and general regulations.

ARTICLE X.

The forms of registry and returns from Grand Lodges, of the election of Grand Officers and appointments of proxies, shall be prepared in compliance with these Grand Regulations, by the National Grand Secretary, and duplicate copies published with the proceedings.

ARTICLE XI.

It is the duty of every Grand Lodge held under the jurisdiction and Masonic authority of the M.W. N. Grand Lodge, to make its returns to the National Grand Secretary annually, and of the Secretary of every such Grand Lodge to prepare such returns.

PROCEEDINGS IN NATIONAL GRAND LODGE.

ARTICLE I.

SEC. 1. When five or more Grand Lodges are represented, the National Grand Master or other presiding officer takes the chair, and upon his call, the brethren take their seats. The Grand Masters or proxies, and Past Grand Masters of State Grand Lodges, take place on the left hand of the National Grand Master, according to seniority of their respective Lodges: and in like manner, the Wardens of the several Grand Lodges take place upon the right, unless invited to other seats by the National Grand Master.

SEC. 2. Visitors cannot be admitted after one hour has elapsed from

the stated time of meeting of the National Grand Lodge.

SEC. 3. At the third stroke of the N. G. Master's gavel, or when he rises and calls to order, there shall be a general silence, the members keeping in their seats under the penalty of a public reprimand.

SEC. 4. Every question, moved and seconded, (when in order,) shall be put by the presiding officer; and no matter shall be entered upon,

until that under consideration be first decided.

SEC. 5. No brother shall speak more than twice to the same question without special permission, or to explain himself. The presiding officer determines all questions of order.

SEC. 6. On the call of five members, a majority of the National

Grand Lodge may demand that the previous question be put.

SEC. 7. If a member be twice called to order at one session, and he offend again, the presiding officer may peremptorily command him to quit the room, and he shall be excluded during the time of meeting in which he has thus offended.

SEC. 8. Every one that speaks shall rise, and continue standing, and address himself in a proper manner to the chair. He shall not be interrupted or called to order, except by or through the presiding officer: when called to order he must sit down, but being corrected, may again proceed.

SEC. 9. The votes of the members, on all questions proposed by the chair, shall be taken by the show of hands, unless a ballot be required by any one Grand Lodge, in which case such ballot shall be taken.

SEC. 10. No vote shall be taken, at any extra session of the National Grand Lodge, touching any charge by or against any Lodge, or its pecuniary interest, unless previous reasonable notice has been given to such Lodge or its proxy.

SEC. 11. No committee charged with disbursements of monies shall

be considered as finally discharged until all the debts contracted by it have been paid.

ARTICLE II.

OF TRIALS AND THEIR INCIDENTS.

SEC. 1. When a controversy shall arise between Grand Lodges, or between a Grand Lodge and its M. W. Grand Master, or between a Grand Lodge and a member or members of another Grand Lodge; or members of different Lodges; and charges be preferred thereupon, it shall be the duty of the National Grand Lodge, when in session, by resolution, or of the National Grand Master, during the recess, by warrant, to appoint not more than seven, nor less than three, disinterested Commissioners, to hear and determine the same; Commissioners may, in like manner, be appointed at the discretion of the National Grand Master or National Grand Lodge, in case of a difference between the National Grand Lodge and one of its State Grand Lodges.

SEC. 2. The Commissioners shall have attained the rank of Grand Master or Grand Warden, and shall be selected from at least three Grand Lodges, not interested in the matter, most convenient to the

parties and their witnesses.

SEC. 3. After service of the charges, the Commissioners shall appoint a time and place for the trial, convenient to all parties, and summon the parties and their witnesses at the request of either party.

SEC. 4. When a trial is concluded, the Commissioners shall, as soon as possible, make their report of the facts found by them, and their judgment upon the matter, and give notice thereof to each of the parties, and a majority of the Commissioners must concur in the judgment; a duplicate copy of which report shall be filed with the National Grand

Secretary.

SEC. 5. The decision of the Commissioners shall be final, unless an appeal be taken therefrom to the National Grand Lodge at its next Triennial Session, in which case it shall be the duty of the Commissioners, upon receiving notice of such appeal, to transmit their report to the National Grand Secretary, unless they have already done so. The appellant shall also, within sixty days after notice of the decision, give notice of the appeal to the opposing party.

SEC. 6. The appeal shall be heard in National Grand Lodge, or before a committee thereof, during its session, upon the appeal and report of the Commissioners, and any documents accompanying the same; and the decision of the National Grand Lodge upon the appeal shall be

be conclusive upon all the parties.

SEC. 7. When charges are preferred in a Grand Lodge against a member, Commissioners shall be appointed in like manner from among its members in all respects like the preceding, so far as the same is ap-

plicable, subject to a like appeal.

SEC. 8. The expenses which may be incurred by Commissioners appointed under the provisions of this title shall be borne by one or both of the parties, as shall be decided by the Commissioners, and the amount

of such expenses, and their decision as to who shall be chargeable with the same, shall be set forth in their report, and payment may be enforced in the same manner as Grand Lodge or National Grand Lodge dues.

SEC. 9. Charges against a M. W. Grand Master of a M. W. Grand Lodge, for official misconduct while holding the office of Grand Master, shall be filed with the National Grand Secretary only during his term.

SEC. 10. In all cases when a charge is presented, the accused shall be served with an attested copy of the charges, ten days, at least, previous to the time appointed for the examination; *Provided*, the residence of the accused shall be known, and shall be within fifty miles of the place where the Lodge having the matter in hand is located. If the residence of the accused be at a greater distance than fifty miles, then, and in that case, a summons to appear and show cause, forwarded to him by mail or other conveyance, twenty days, at least, before the time of trial, shall be considered sufficient service. If his residence be out of the State, and unknown, the Lodge may proceed to examine the charges, ex parte; but, if otherwise, four months, at least, before the time appointed for the examination.

SEC. 11. The accused may select any brother for his counsel, and the witnesses shall testify, if Masons, on their honor as such. Hearsay

evidence shall be excluded.

SEC. 12. When a trial shall go to a Grand Lodge under an appeal, the question, "Is the accused guilty or not guilty?" shall be distinctly put to each member of the Grand Lodge, by name, commencing with the youngest. The answer shall be given standing, and in a distinct and audible manner. The Grand Secretary shall record the answer as given.

SEC. 13. If the verdict be suspension or expulsion, the name of the person so suspended or expelled shall be sent to the National Grand

Secretary, and if no appeal be taken, the action shall be final.

SEC. 14. A sentence of expulsion shall not take effect until confirmed by the Grand Lodge of the jurisdiction, but shall operate as a suspension of the delinquent in the mean time. In all cases, a majority of two-thirds shall be necessary to suspend or expel.

ARTICLE II.

OF PENALTIES.

SEC. 1. The penalties imposed by Masonic law, are,

1st. Suspension, which is either limited or indefinite; and,

2d. Expulsion, which always implies a termination, not only of Masonic intercourse and connection with the body inflicting it, but from the Masonic Fraternity, unless an appeal be made.

SEC. 1. Suspension applies to a Grand or subordinate Lodge, as well as individuals, and when inflicted upon a Lodge, it suspends all its members, unless expressly excepted. Suspension and expulsion imply interdiction of all Masonic intercourse with the delinquents, while in force.

SEC. 3. Suspension is only inflicted where the offence is against some police or temporary regulation of the Fraternity; expulsion follows a gross violation of the moral law, or the fundamental principles of Masonry, or attempts against any part of the framework of its government. Neither shall be published to any but Masons, except by permission of the Grand Lodge.

SEC. 4. A Lodge may pronounce sentence of indefinite suspension, which shall be final, unless appealed from within six months of the knowledge of the sentence, and reversed or modified on such appeal by the Grand Lodge. But the Grand Lodge may, on application, after one year from the sentence, restore any one suspended or expelled by a Lodge or the Grand Lodge.

ARTICLE III.

OF FUTURE AMENDMENTS AND NEW REGULATIONS.

SEC. 1. No amendment to this Constitution shall be made, or have any effect, until it shall have been proposed in the National Grand Lodge, at its triennial session, and been adopted by the National Grand Lodge at the same session; and in addition to the adoption thereof, at one such triennial session, it shall, during the next three years succeeding, and before the next triennial session thereafter, be adopted by the affirmative vote of the majority of Grand Lodges under the jurisdiction. If such amendment be adopted, it shall be appended to the published proceedings at the end, under the caption, "Amendments to the Constitution," and sent with the printed proceedings to all the Most Worshipful Grand Lodges under the jurisdiction.

SEC. 2. No general regulation shall be adopted, inconsistent with this Constitution and all former written constitutions are hereby, on the adoption of this Constitution, repealed; and all general regulations heretofore made and adopted, inconsistent with this Constitution,

are hereby, also repealed.

SEC. 3. The business of the National Grand Lodge is taken up in the

following order:

1st. The minutes of the preceding triennial session and intervening meetings are read.

2d. Petitions read and referred.

3d. Reports of committees made and read. 4th. Returns from the Grand Lodges read.

5th. New business offered.

This order of business may be dispensed with by the presiding officer.
