### ABOUT THE AUTHOR

Dr. Mervin B. Hogan is recognized among Masonic students as one of the outstanding authorities on Mormonism and it's relation to Freemasonry of the present day.

Both his professional and Masonic credentials are extremely impressive. He was educated at the University of Utah, BSME 1927, the University of Pittsburgh MSME 1929, the University of Utah ME 1930, the University Michigan PHD 1936 and Yale University, Sterling Fellow (post-doctoral fellowship) 1937-1938.

From September 1927 through January 1931 he was employed by the Westinghouse Electric Corp. in East Pittsburgh Pa. where he graduated from the Graduate Training program and the Advanced Design Course. He also worked on mechanical development and design problems related to large rotating equipment. In January of 1931 he went to the University of Utah in Salt Lake City, where he served as Professor and Chairman of the Department of Mechanical Engineering. In addition to his teaching and administrative duties he carried on his private research and was available for duties as a personal consultant. On leaving the University, he spent 13 years working for General Electric Defense Electronics in Syracuse, N.Y. where he was responsible for the Product design and production of the ground based guidance equipment for both the Atlas and Mistram guidance systems. Since 1965 he has made his home in Phoenix, Arizona where he is employed by General Electric Computer Engineering as Manager of Design Review.

In addition Dr. Hogan is a Fellow ASME, Fellow Institution of Mechanical Engineers (London) a Senior Member IEEE has a PE license from New York, Michigan, Connecticut and Utah. He is the author of over 30 technical papers or monographs.

Masonically Dr. Hogan is a Past Master, a former Grand Orator of the Grand Lodge of Utah, a member of both rites and a 33 degree Scottish Rite Mason. He is a member of the Missouri Lodge of Research, the American Lodge of Research, (New York) Quartor Coronati 2076 (London) and a host of affiliated bodies.

He is a frequent contributor to such outstanding Masonic publications as the Philaethes magazine, the Royal Arch Mason, the New Age, and many others. In addition to these he has authored a number of fine Masonic articles for the various research organizations to which he belongs. He has concentrated his research mainly on the Mormon Lodges in the middle west and the relation between Mormonism and Masonry in the present day in the western states, particularly as it exists in the state of Utah. In addition to this work he has also written a number of articles relative to geometry and its relationship to Masonry.

His work as it pertains to Mormonism and Freemasonry has been checked and authenticated by both the Council of Twelve of the Latter Day Saints Church and the Grand Lodge of Utah.

An appreciable number of renowned contributors to the history of the West, and particularly the Inter-Mountain Empire, were members of Nauvoo Lodge U.D. of Nauvoo, Illinois. In many cases one is hard put to separate those who immortalized themselves as leaders of the Church of Jesus Christ of Latterday Saints and the State of Utah from those included in the same capacity in the history of the generic West itself.

Hyrum Smith was a moving spirit in the organization of the Lodge and served zealously as the Worshipful Master *pro tempore* until the time of his death. Joseph Smith and Sidney Rigdon were accorded within the Lodge the ultimate honor of Freemasonry: that of being made Masons at Sight. This highly unusual recognition was conferred upon them by Abraham Jonas, the Grand Master of the Grand Lodge of Illinois. Brigham Young, John Taylor and Wilford Woodruff, who successively followed Joseph Smith as President of the Mormon Church, received the Degrees of Masonry within the Lodge. Almost every one of the early Apostles, together with many other leaders of the Church at various echelons of responsibility, was likewise made a Mason within the Hall of Nauvoo Lodge.

These noted leaders and pioneers are of special interest to students and scholars concerned with the history of the times and places spanned by the accomplishments of these frontiersmen of singular conviction and demonstrated fortitude. Since there is a large and ever increasing living progeny of these historic progenitors, there is a definite interest in the record which they wrote on the archway of time.

The available record of Nauvoo Lodge consists of the Minute Book of the Lodge and two pages of members' signatures affixed to the Lodge By-Laws. The latter are evidently removed from the original volume containing the By-Laws which, by immemorial Masonic usage and tradition, must be signed by the newly Raised Mason before he attains full member status in the Lodge.

These historic documents are in the Archives of The Most Worshipful Grand Lodge, Ancient Free and Accepted Masons, of the State of Illinois, at Rushville.

The Minutes comprise forty handwritten pages executed by the perjured and foresworn John Cook Bennett. By outright prevarication and misrepresentation he succeeded in being elected and duly installed as Secretary of the Lodge although he was under the sentence of expulsion from Pickaway Lodge No. 23 of Circleville, Ohio.

Bennett's longhand is distinctive in style and marked by a number of personal idiosyncrasies. It is characterized by the smooth and uniform fluency attained by one who daily employs his handwriting extensively in the performance of his vocation. It took me considerable time to become fully adjusted to the intricacies of his style so as to read the record with assurance, confidence, accuracy and ease.

As a secretary, Bennett's record leaves much to be desired. He consistently employs throughout his writing a stereotyped, dull, routine style and covers only the bare essentials pertaining to the Lodge transactions. As you read page after page, you wish he had had the interest and a bit of imagination which would have provoked him to record some of the many occurrences of

human interest pertaining to personal relations and individual exchanges. He is inaccurate and indifferent to the spelling of the names of both men and places and generally careless with the assignment itself.

Hyrum Smith's signature as Worshipful Master *pro tem* is somewhat stilted and in the copy-book style. The flourishes and the pen marks clearly indicate one who does not regularly or extensively utilize his hand in penmanship. This is even more marked and true for each of the few other men who signed the Minutes in the same capacity.

The signatures appended to the By-Laws span the spectrum of handwriting quality and styles. In a few cases one suspects that the scarcely decipherable and almost illegible signature indicates the possible limit of both the man's spelling and writing. In striking contrast is the impressive and unique signature of Parley P. Pratt which unquestionably ranks him as the John Hancock of Nauvoo Lodge. Approximately three times the height of any other associated signature, written vertically down the center of the page, its pronounced and appealing fluency is that of a man who knows he is an outstanding penman and is proud of the fact.

RECORD OF NAUVOO LODGE UNDER DISPENSATION

Copy of Dispensation.

“To all who shall see these presents –

Whereas it appears to me, from the petition of sundry Brethren of Hancock County, in the State of Illinois, who are recommended and vouched to me, as worthy and fit Master Masons, by the Master, Wardens, and Brethren of Columbus Lodge, No. 6, held at Columbus in said State, that the congregating of said petitioners, and others, who they may think proper to admit into their lodge (when organized) will tend to promote the welfare and usefulness of the craft – and

Whereas lodges of masons in the recess of the Grand Lodge of the State of Illinois can be formed under its jurisdiction by special dispensation only –

Wherefore, I, Abraham Jonas, Grand Master of the said Grand Lodge of Illinois, do hereby, as Right Worshipful Grand Master of the Grand Lodge aforesaid, and according to the Constitution of Ancient York Masons, Grant this dispensation hereby authorizing and empowering our trusty and well beloved brother, George Miller, of said County of Hancock, to congregate a sufficient number of worthy brethren at some convenient place in the ‘City of Nauvoo, in said County of Hancock, and then and there, with convenient dispatch to form and open a lodge after the manner of Ancient Masons, – and in pursuance of the petition aforesaid, I do hereby appoint our said brother, George Miller, Esq., the first Master, – John D. Parker to be the first Senior Warden, – and Lucius N. Scovil to be the first Junior Warden of the Lodge of Masons aforesaid, and to be opened and held at the said ‘City of Nauvoo’ as aforesaid, and to be known by the name of Nauvoo Lodge under dispensation - and I do further authorize the said Master, Wardens, and such Brethren as they may admit as members of said lodge, and their said lodge, when duly formed and opened, to enter, pass, and raise to the Sublime Degree of Master Mason, all such as may be, by *all* the members of said lodge, deemed worthy, according to ancient custom, *and not otherwise*, with the intent and view that the brethren who may be so congregated, entered, passed, and raised may in due time, be duly warranted for being and holding a regular lodge, for the further promoting the Craft and increasing the number of Worthy Brethren – Provided, however, that this Dispensation do continue and be in force, until the next annual session (1st Monday in October 5842) of the Grand Lodge aforesaid, *and no longer*.

Given under my hand and private seal, at Columbus, in the State of Illinois, on this 15th day of October, A. L. 5841, and A.D. 1841.

George Miller, Esq., Master of Nauvoo Lodge under Dispensation, congregated the following brethren at the office of brother Hyrum Smith; to wit: George Miller, Hyrum Smith, William Vanansdall, Joshua Smith, N. K. Whitney, William Felshaw, Austin Cowles, L. N. Scovil, Charles Allen, John Smith, Lyman Leonard, Hiram Clark, Samuel Rolfe, David Pettegrew, Christopher Williams, John Patten, John C. Bennett, and Heber C. Kimball.

The dispensation from Grand Master Jonas, dated 15th Oct. 5841, & 1841, was accepted. Brother Hyrum Smith was elected Senior Warden *pro tempore*; John C. Bennett, Secretary; N. K. Whitney, Treasurer; Charles Allen, Senior Deacon; Heber C. Kimball, Junior Deacon; William Felshaw, & Hiram Clark, Stewards; and Samuel Rolfe, Tyler.

John C. Bennett, H. C. Kimball, & George Miller, were appointed a committee to draft, & report a code of by-laws for the government of this lodge. The lodge, which was not opened in due form, then adjourned to meet again on the 30th Inst., at 6 o'clock, P.M., at the same place.

The lodge met pursuant to adjournment. Present – George Miller, Worshipful Master; Hyrum Smith, S.W., p.t.; L. N. Scovil, J. W.; John C. Bennett, S.; Charles Allen, S. D.; H. C. Kimball, J. D.; Wm. Felshaw & Hiram Clark, S.; S. Rolfe, T.; and Wm. Vanansdall, Joshua Smith, John Smith, Lyman Leonard, C. Williams, John Patten, Noah Rogers, Samuel Henderson, Elijah Fordham, & Asahel Perry, Members. John Smith was appointed Treasurer *pro tempore*, and the lodge was opened in due form in the Entered Apprentices’ Degree. The Committee on By-Laws then reported the following code, which was unanimously adopted; to wit:

“By-Laws of Nauvoo Lodge, under dispensation.

Meetings.

Sec. 1. The stated meetings of this lodge shall be on the 1st and 3rd Thursdays of every month, commencing at 6 o'clock, P.M.; Provided, that the first stated meeting shall be on Thursday, the 30th day of Dec., A.L. 5841, A.D. 1841.

Duty of Officers.

Sec. 2. It shall be the duty of the Master to preside, preserve order, and

cause the by-laws of this lodge, and the usages of masonry, to be duly observed; to call emergent meetings when necessary; to take the voice of the lodge on all questions brought before it; and to perform such other duties as pertain to his office.

Sec. 3. The Senior and Junior Wardens, Secretary, Treasurer, Senior and Junior Deacons, Stewards, and Tyler, shall severally perform such duties as appertain to their respective stations by the usages of Ancient York Masonry.

#### Of the Members.

Sec. 4. A member wishing to speak shall rise, and address the presiding officer.

Sec. 5. No one shall speak more than twice on the same subject, unless to explain, without permission from the lodge.

Sec. 6. While the presiding officer, or any member, is addressing the lodge, or a member the presiding officer, no one shall leave his seat, or hold private discourse.

Sec. 7. Disorderly conduct shall be punished by admonition, suspension, or expulsion, as the case may require: Provided, however, that no one shall be expelled without the concurrence of two-thirds of all the members of the lodge.

Sec. 8. Should any member disclose to any person other than Ancient York Masons, in good standing, any of the proceedings or transactions of this lodge, improper to be made public, he shall be suspended, expelled, or otherwise dealt with, at the discretion of the lodge.

#### Order of Business.

Sec. 9. Reading the minutes of the preceding meeting shall always be first in order; presentation of petitions next; reports of committees next; balloting for members, and the initiating, passing, and raising, shall follow; after which any miscellaneous business.

#### Initiations, etc.

Sec. 10. Every person desirous of being initiated into this lodge, must prefer a petition in writing, stating his age, profession, trade, or occupation, and place of residence, which must contain a deposit of five dollars, as a fee for initiation, and be recommended by two master masons, one of whom must be a member of this lodge.

Sec. 11. If the petition be received it shall be referred to the standing committee of investigation, to report thereon at the next stated meeting.

Sec. 12. If the applicant be rejected, the member who handed in his petition shall return him his deposit with delicacy and politeness, and no member shall make known the fact of such rejection to any person other than the rejected, or the members of this lodge, or other masons, unless the person rejected should himself first make it public.

Sec. 13. Every brother desirous of being advanced in masonry; must undergo an examination in open lodge, touching his skill in the degree, or degrees, already taken; or be vouched for by a master mason.

#### Fees.

Sec. 14. The fees of this lodge shall be as follows; to wit: for initiating, five dollars — passing, three dollars — raising, seven dollars — and the reception of members not made in this lodge, two dollars: to be recovered from all persons hereafter received.

#### Voting.

Sec. 15. No candidate shall be initiated without the unanimous consent of the lodge.

Sec. 16. In electing officers, a majority of all the votes given shall be necessary to make a choice.

Sec. 17. Members can only be excused from voting by the lodge.

#### Committees.

Sec. 18. All committees shall be appointed by the presiding officer, unless in particular cases the lodge should direct otherwise.

Sec. 19. The following standing committees shall be established; to wit: A Committee of Investigation, to consist of three members, to inquire into the character of all applicants.

A Committee of Claims, to consist of three members to whom shall be referred all matters of claims against the lodge.

A Committee of Ways and Means, to consist of three members, to whom shall be referred all subjects of taxation and revenue; — and

A Committee of Charity, to consist of the Master, and Wardens, to whom shall be referred all matters and applications requiring charitable appropriations.

#### Dues.

Sec. 20. Each member of this lodge shall pay the sum of fifty cents as quarterly dues.

### Fines.

Sec. 21. For non attendance at any stated meeting, the delinquent member shall be fined twenty-five cents, unless an excuse, satisfactory to the lodge, be presented at the succeeding stated meeting.

### Charity Fund.

Sec. 22. One half of the fees for initiations, passings, and raisings, after defraying expenses, shall be appropriated to the charity fund.

Sec. 23. These by-laws may be amended at any time by a vote of two-thirds of the members of the lodge, - by giving one month's previous notice, at a stated meeting.

Heber C. Kimball, John C. Bennett, and N. K. Whitney, were appointed the standing Committee of Investigation.

Hyrum Smith, L. N. Scovil, and Charles Allen, were appointed the standing Committee of Claims; and Elijah Fordham, Samuel Rolfe, and Lyman Leonard, were appointed the standing Committee of Ways and Means.

Some of the brother Masons turned on Joseph Smith and the Church and were closely related to the brutal and tragic murders at Carthage Jail and the consequent heartache, grief and terrible tribulation. The interested and informed peruser will find much of vital consequence in these Minutes of an undertaking in brotherhood which started with enviable and exemplary enthusiasm, yet closed in disillusionment, hatred, strife and bloodshed.
